University of Stavanger 23-24 May 2022

About PROFRES

PROFRES is a national doctoral research school addressing three key areas of the welfare state: health, welfare and education. PROFRES 1.0 was established in 2014 as a collaboration between the Universities of Stavanger, Agder and Nordland (now Nord) and South-Eastern Norway. 42 PROFRES-candidates have successfully defended their theses. In January 2022, our proposal "PROFRES 2.0: The Interdisciplinary, Interprofessional and Practice-Near Research School, " was granted funding by the Research Council of Norway.

In 2.0, we collaborate in an extended consortium of higher education institutions in Norway: the Universities of Stavanger (project owner), Agder, South-Eastern Norway, and North, as well as University Colleges Vestlandet, Volda and Molde, with Østfold University College as an associate partner. Our international partners are Roskilde University and Tallinn University. We also collaborate with KS, Stavanger Municipality, Bufetat Sør, NIFU, Center for Social Entrepreneurship (RUC), HealthCampus Stavanger and Worldwide Narratives in a ThinkTank tasked with developing 2.0's relevance to society through co-creation and knowledge exhchange.

PROFRES 2.0 is profoundly preoccupied with conditions in working life, as evident in our remit for practice-near and professionsoriented research problems. Through our partner consortium we recruit participants from 14 PhD-programmes in Norway, which altogether enroll over 800 PhD candidates. We offer these participants an integrated academic programme, designed to deliver excellence and relevance by strengthening relations between HE and labour sectors, in line with policy makers' ambitions. This includes emphases on interprofessionalism and the need for creative interdisciplinary collaboration in order to address and resolve major challenges in the welfare state, without compromising its basic values.

The overarching aim of PROFRES 2.0 is twofold and complementary:

- to cultivate excellence in a high-quality interdisciplinary and interprofessional learning environment for practice-near doctoral researchers, with focus on three major labour sectors in the welfare state.
- to vouchsafe relevance by facilitating new co-creation spaces between academic and practice fields – mutually cultivating innovative knowledge-based professional practice and practice-near research.

Core activities will revolve around the questions:

How do you do it? – referring to ambitions for excellence in research, exemplified by ongoing attention to research skills and methodological coherence, as well as themes in PhD courses, supervision and research workshops;

Why do you do it? – referring to ambitions for relevance – the "so what?" of PhD research: learning to connect professional and researcher identities, and to identify and communicate implications for practice; and

How can you survive it? – signaling our determination to support emerging PhD researchers and their career development, while sustaining psychosocial wellbeing.

Shaping Future Welfare

This kick-off is a celebration of PROFRES 2.0, funded by the Research Council of Norway for the period 2022-2030. The event is our first step towards establishing collective wondering about how we, as an interdisciplinary and interprofessional community of practice-near researchers, can contribute to shaping future welfare.

Thematically, PROFRES 2.0 addresses both current and timeless challenges facing the welfare state. These are challenges often characterized by complexity, contradiction, and uncertainty. Corresponding moral dilemmas and ethical pressures can emerge for professional practitioners within the welfare state, who must negotiate between societal needs and policy makers' ambitions - and the multilayered values and knowledges that guide their relationship-based work with endusers. With increasing needs and demands in the population and more stretched human and economic resources, questions are being asked about the very sustainability of public welfare itself. Added to this backdrop, is the urgency of major global problems like the climate crisis, the covid pandemic and destabilization of international relations and democracies, highlighting our implication in new vulnerabilities. interrelatedness and responsibilities beyond national borders and the professional practice fields of the welfare state.

In the light of this, we ask: what is the future of welfare, and how can 2.0 contribute to its formation and ethical sustainability?



To begin to address these questions will require dreaming, wondering and reflection, as well as new modes of engagement between the research and practice fields. We therefore bring together junior and senior scholars, professional practitioners, social entrepreneurs, educators, leaders and policymakers to co-create around practice-near research over our eight-year project period. In this way, PROFRES 2.0 develops and upholds hope for a progressive welfare future, establishing new arenas for knowledge exchange as vehicles for impact along the way.

It is with great pleasure that I welcome you as a participant in this kick-off. It marks the continuation of a well-established collaboration to support and develop PhD candidates through their journeys, as well as being the start of a whole new adventure.

CELEBRATORY DINNER AT JERNALDERGÅRDEN (by invitation and registration only)

The Iron Age farm at Ullandhaug is a reconstructed farm from the Migration Period, approximately 350 – 550 AD. The farm is located at the top of Ullandhaug, approximately 3 km from Stavanger city centre, with magnificent views of Nord-Jæren and Hafrsfjord. As the only one of its kind in Norway, the Iron Age Farm has been rebuilt on the original remains and ruins of a farm that dates back to the Migration Period. The three houses are furnished with equipment and household utensils, and there are open fires burning in the original fireplaces.

The menu is based on ingredients that were available even in prehistoric times. The principles of preparation are the same, but the presentation of dishes is adapted to the times we live in now.

How being in wonder can qualify your research question and research focus on "die Sache"

Facilitated by Professor Finn Thorbjørn Hansen, Aalborg University, Denmark

In this workshop we will work with a Wonder Lab (Hansen, 2015; Visse, Hansen & Leget, 2020; Hansen & Jørgensen, 2021). This kind of wonderbased dialogue practice has been used when focusing on phenomenological dimensions and tacit philosophical assumptions in professions such as in health, education, and welfare. It has also been used in training PhD-students in cultivating a deep contemplative kind of wonder from within certain significant lived experience in their research projects and empirical cases. Wonder Labs may be central to inquiring into how one can rehumanize education, health and welfare through a new existential and phenomenological approach.

DEVELOPING THE PRACTICE OF CARE IN AN UNCARING WORLD

Keynote lecture by Emeritus Professor Paul Hoggett

Over several decades a climate of uncare has gained strength in the Global North which has affected how governments think about both the welfare of citizens and of the natural world. Society's fragile ecology has been subject to the coldly technocratic embrace of neoliberalism, one which subjects everything to measurement and calculation. This performative culture has several perverse effects. It devalues the relational dimension of care, it distances service providers from service users, it privileges appearance over reality and it has a demoralising effect upon professionals.

In the face of this development it is vital to revisit the question of care. What lies at its heart? What contradictions and tensions are inherent to the nature of care? What are 'frameworks of care' and how can they be established? What are the implications for the care of the professionals themselves?

THE FUTURE OF THE WELFARE STATE: HOW AND WHY IT MATTERS

Keynote lecture by Professor Halvard Vike

The welfare state is a great paradox. It first emerged under authoritarian conditions. and as a political program it did not draw much support in the most developed democracies. In the post WW II era, it was solidly institutionalized in most democracies, and for some time seemed to represent "the end of history" – the only possible way to curtail social destructive conflict and deep inequality, and to achieve societal integration. However, since the 1980s its fragility has been clearly revealed, and popular support for the welfare state has been declining. In the Nordic countries, however, this tendency is clearly less dominant, and the overarching vision of universalism has not been undermined.

In my contribution to this event, I would like to reflect on universalism - what it means, how it is possible to achieve, and how it may be reproduced under new conditions. As one of the leading theorists of the welfare state Gösta Esping Andersen has demonstrated, the Nordic model of the welfare state emerged as an aspect of "the politics of solidarity". Services and benefits were granted independently of social status, and to a large extent they were needs-driven and of high quality. Our challenge today, it seems to me, is to prevent services and benefits from becoming conditional, increasingly targeted, and of lower quality. This depends not only on popular political support for the welfare state as such, but also in institutional capacity and on the agency of those responsible for the day-to-day work: the professions. If services are mainly provided for the poor, services become poor, to rephrase Richard Titmuss.




Until quite recently, the service-providing professionals in the Nordic welfare state have worked under conditions characterized by a high degree of autonomy and a relatively decentralized power structure. Although these conditions are changing, they still inform professionals' identity, motivation, and dedication to their work to a great extent. Insofar as the quality of the welfare state depends more heavily on these factors than previously understood, it may be fruitful to reflect more systematically on how they may be reproduced under new conditions.

BJØRN ARILD ERSLAND



FINN THORBJØRN HANSEN

Finn Thorbjørn Hansen is Professor of Applied Philosophy at the Department of Communication, Aalborg University. His main research interest is on the phenomenology of wonder, and how one can work with wonder-based dialogues and practice-oriented phenomenology in professional settings. He is the founder of The Danish Society of Philosophical Practice (www.dsfp.dk), and he has developed a unique Socratic and phenomenological-oriented action research method. PAUL HOGGETT

Paul Hoggett is Emeritus Professor of Social Policy at UWE, Bristol where he was also Director of the Centre for Psycho-Social Studies. He originally worked in community mental health before moving into research at Bristol University on community studies and later on public service reform. He never abandoned his interests in mental health and after twenty years in research he undertook a training in psychotherapy. This enabled him to contribute to the development of psycho-social studies in the UK, an approach to research and practice which focuses on the constant traffic between citizens' inner lives and the outer worlds in which they live. He left academia several years ago to work in private practice as a psychotherapist and to help develop action around climate change by setting up the Climate Psychology Alliance, Hoggett is the author and editor of books on topics ranging from emotional life and the politics of welfare to research methology and climate psychology.



HALVARD VIKE

Halvard Vike is professor of anthropology/ welfare studies at University of Southeastern Norway. He is the author of numerous books and articles that engage critically with the welfare state - its emergence, dynamics, transformations and possible future, including Politics and Bureaucracy in the Norwegian Welfare State (Palgrave MacMillan, 2018), and Egalitarianism in Scandinavia, Historical and Contemporary Perspectives (with Synnøve Bendixen and Mary Bente Bringslid, Palgrave Macmillan 2018). Vike's research interests also include historical anthropology and sociology, language, research ethics, politics, power and democracy.

Halvard has been external reader to PROFRES 1.0 candidates and contributes to PROFRES 2.0 as a guest leturer in the Autumn PhD course (see p. 16)



ALI ROY

Ali Roy is Professor of Social Research and Co-Director of the Psychosocial Research Unit, University of Central Lancashire, UK. Before becoming an academic Roy was youth and community worker and residential social worker. Rov is an interdisciplinary scholar, with a particular interest in research methodology. He has worked on innovations in mobile. visual, narrative and participatory methods. He has also undertaken applied research in the fields of substance use, mental health, youth homelessness as well as in participatory and collaborative arts.

Maria G. Volckmar-Eeg works with projects related to integration and welfare. She has a particular interest in how welfare services meet and accommodate an increasingly diverse population. Her research interests include welfare policy, ethnic and cultural diversity, street-level discretion, labor market integration, and professional social work. In her doctoral thesis, Volckmar-Eeg explored how frontline workers in the Norwegian Labor and Welfare Administration (NAV) operationalize the category of 'immigrant clients', with a particular focus on how they emphasize culture in this work, and the implications of such categorization for further case proceedings.

Maria is a PROFRES 2.0 Alumni. She was PROFRES 1.0 PhD representative, and has contributed to the working group behind the proposal for PROFRES 2.0.



ASLAUG KRISTIANSEN

Aslaug Kristiansen is Professor of Pedagogy at the University of Agder. Her research interests are ethics, dialogue, democracy, teachers' work and pedagogical philosophy. She is currently involved in research projects aimed at teacher qualifications, and in particular those that deal with value and attitude development. In addition, projects that shed light on the classroom environment and teacher teaching in terms of preventing the development of racist, anti-Semitic and polarizing ideas.

JONNA LAPPALAINEN

Jonna Lappalainen is Professor at Södertörn University. She wrote her thesis (Den Enskilde: En studie av trons profana möjlighet i Sören Kierkegaards tidiga författarskap) in philosophy on Søren Kierkegaards understanding of "the single individual". Lappalainen participates in an ongoing research project on collective practical knowledge. The project combines philosophical investigations of the concept of "collective phronesis" with a study of how professionals in the education system ande the police force in Sweden and Germany understand and relate to this very concept. In recent years she has conducted research on the role of thinking in higher education and how it has changed over the last 20 vears of transformations in the education system. She works as lecturer at the Center for practical knowledge.

Reflective Processes in Professional Practice

PhD course (5 ects), University of Agder

Professional work within health, education, welfare, and social work develops within local, national, and international contexts. Reflexivity is to see and understand oneself within a context. Through this course the students will develop their ability to reflect, theorize and understand themselves and professional work. Students will be encouraged to develop and problematize their subjectivity in relation to their background and professional position, and to explore and challenge different understandings of professionalism. The students will develop a contextual and ethical awareness that can inform their current PhD project. The aim of the course is to enable participants to strengthen their critical reflection and increase their understanding of interactional, contextualized, situational and collaborative practices. To enhance reflective processes the course will provide knowledge about ethics, contexts, and social interaction.

This course is offered in collaboration with the NORHED-project RESILIENT (2021-2026, UiA) to develop social work and research with HE institutions in Rwanda, Uganda and Tanzania.



International PhD Summer School August 23– 26 2022 in Roskilde

Methodological Issues

PhD course (5 ects), University of Roskilde

The Summer School is organized by the Doctoral School of People and Technology, Roskilde University (DK) in collaboration with PROFRES, The Interdisciplinary, Interprofessional and Practice-Near Research School (NO).

The Roskilde University International Summer School IMT has provided a decade-long tradition of dynamic doctoral training based on critical reflection and interactive forms of learning. Our significant focus is a continuous interest in methods and methodology and how this relates to research questions, theory, concepts, analyses and empirical findings. This year's summer school will focus on methodological issues informed by theory. The ambition is to present and discuss research approaches in which we seek transparency and critical reflections on methods, methodology and how these choices form our analysis, representations, and texts. Such activities might include issues of subjectivity and discourses, learning and societal contexts that help us reframe and rethink qualitative research in learning, health, cultural activities, and participation in civil society, work life, social innovation, and families. The Summer School will also address basic questions of theory and epistemology and stimulate discussion of the role of researchers and their engagement in issues of societal importance – and how this might influence our research.
